***RPL Type 1 (Camps) and Type 2 (Employer Premises)***

National Skill Development Corporation (NSDC) invites proposals from organizations that meet the eligibility as mentioned in the RFP document for the implementation of skill certification under RPL in PMKVY 3.0. 4. No other form of submission including hard copy will be entertained. The deadline for the submission of applications is **19<sup>th</sup> February 2021**.
